NRCS Report – Thane Espe gave an update from the NRCS. Workload continues to be with the Conservation Stewardship Program (CSP), Environmental Quality Incentives Program (EQIP) and the Continuous Conservation Reserve Program (CCRP).

Marshall SWCD New Business:

- District Manager Carlson brought up that it is an Election Year. Supervisors Brent Miller and Carl Green have terms that end this year (2024) and will need to decide if they would like to run again.

- Year End Reporting District Manager Carlson gave an update on the year end (2023) reporting on the numerous grants that the Marshall SWCD are working on.
- Thief River 1W1P District Manager Carlson gave an update on the Thief River 1W1P. Policy Meeting is scheduled for March 11, 2024 at the Red Lake Watershed District at 9 a.m.
- Middle/Snake/Tamarac 1W1P District Manager Carlson gave an update for the M/S/T 1W1P. Next Policy Meeting is scheduled for March 13, 2024 at 1 p.m. at the Marshall SWCD Conference Room. Carlson gave an update on the Supplemental Funds, Swift Coulee Project and the CCRP Funds Incentives. Also discussed was the new Project Worksheet/Ranking Sheet for projects. Ranking projects using this scoresheet may potentially show the need for some projects to receive up to 90% cost share assistance. The Marshall SWCD Board liked the project/scoring worksheet.
